COMPETITION TERMS AND CONDITIONS



1. INTRODUCTION

- 1.1. These are the standard Terms and Conditions for the Progressive Jackpot online Competition conducted by ITHUBA Holdings RF (Proprietary) Limited ("ITHUBA and/or Promoter").
- 1.2. Participants entered into the competition acknowledge that they have been allowed to review these Terms and Conditions. Moreover, they understand and accept these Terms and Conditions.
- 1.3. These Terms and Conditions will prevail in the event of any conflict with any other communications sent to you by ITHUBA and its partners.

2. THE CONSUMER PROTECTION ACT 68 OF 2008 ("CPA")

- 2.1. These Terms and Conditions contain certain provisions which may:
 - 2.1.1. Limit the risk or liability of the ITHUBA, or any relevant third party;
 - 2.1.2. Create risk or liability for the Participant;
 - 2.1.3. Compel the Participant to indemnify the ITHUBA or a relevant third party; and/or
 - 2.1.4. Serve as an acknowledgment, by the Participant, of certain facts.

3. THE PARTICIPANT

- 3.1. The Participant must be:
 - 3.1.1. A natural person and may not be a juristic person;
 - 3.1.2. 18 years or older;
 - 3.1.3. In possession of a valid South African Identity Document; and
 - 3.1.4. Permanent resident or citizen of the Republic of South Africa residing in South Africa.
- 3.2. It is a material term of the Competition that all Participants' to this Competition participate entirely at their own risk; and

- 3.3. No director, employee, contractor, service provider, agent or consultant of the ITHUBA or organizer, or their spouses, organisers, business partners or immediate family members, or the supplier of goods or services in connection with this Promotion may participate in this Competition.
- 3.4. By playing any National Lottery online game, the Participant will automatically be entered into the draw for the Progressive Jackpot.
- 3.5. Should the Participant wish to be removed from the Progressive Jackpot draw, the Participant must email info@ithubalottery.co.za and indicate same.

4. ENTRY INTO THE COMPETITION

- 4.1. Registered and verified Players that play any of the LOTTO, PowerBall, SPORTSTAKE, DAILY LOTTO or EAZiWIN games on the National Lottery website, mobile-web, or mobile APP will receive an automatic entry to stand a chance to win the Progressive Jackpot.
- 4.2. ITHUBA reserves the right to deem that entry invalid if a Participant has given incorrect details.
- 4.3. The Progressive Jackpot competition is open from 11 September 2023 and ends at 00h00 (midnight) on 22 December 2023.
- 4.4. The Jackpot Winner will be randomly selected from the E-commerce database of registered players, verified, and audited by an internal auditor.
- 4.5. For every R1.00 purchase across any National Lottery online game equates to one entry, i.e. R1.50 equals one entry. A LOTTO ticket at R5.00 equals five entries giving the player more chances of winning.
- 4.6. Participants will be entered each time a National Lottery game ticket is purchased online and will be legible to win the progressive jackpot during the promotional period.

 - 4.10.1. Any and all applicable fees;
 - 4.10.2. All other costs incurred by the Participant or arising directly or indirectly from the Participant's participation in the Promotion or the acceptance, receipt, use or enjoyment of the experience; and
 - 4.10.3. Without limiting the rest of this section, the Participant will be responsible for entering the promotion and any data or call charges that apply, as per the tariff rates charged by the Participant's mobile network provider.

5. THE WINNER

- 5.4. The draw will be performed by ITHUBA (including its Partners) and audited by an internal auditor.
- 5.5. The Progressive Jackpot amount at the time of winning will be deposited directly into the Participant's e-wallet, and the Participant's will receive an SMS to notify them that they have won.
- 5.6. The Winner will be notified of their winning by using their registered and verified contact details as provided in the Participant's National Lottery account profile.

- 5.7. The Progressive Jackpot Winner can withdraw the total winning amount into a bank account of their choice.
- 5.8. All personal information supplied by Participants will be processed in accordance with South African Protection of Personal Information Act 4 of 2013 legislation (POPI Act) and the ITHUBA Privacy Policy, which Policy is available on the National Lottery website.
