Promotional Terms and Conditions



Interpretation

In these Promotional terms and conditions, unless the context clearly indicates a contrary intention, the following words will have the following meanings and cognate expressions will have corresponding meanings:

- **"the Act"** means the Consumer Protection Act 68 of 2008, as amended;
- **"Business Day"** means a day other than a Saturday or a Sunday or a day which from time to time is a proclaimed public holiday in the Republic of South Africa;
- **"Promotion"** means this Promotion being conducted by the Promoter as detailed in these Promotional terms and conditions;
- **"Participant"** means any natural person who qualifies in terms of clause 2.1 hereof and who enters into the Promotion in terms of clause 3 hereof;
- **"POPI"** means the Protection of Personal Information Act, No 4 of 2013, as amended;
- **"Promoter"** means ITHUBA Holdings (RF) (Proprietary) Limited, having its business address at 14A Charles Crescent, Eastgate Extension 4, Sandton, Johannesburg;
- **"Promotional Period"** means: First List opens: 02 May 2022 - Last List opens 30 October 2022.
- **"Website"** means www.nationallottery.co.za;

1. Introduction

- 1.1. The Promoter is offering a Promotion on SPORTSTAKE 8 where players who participate in the game, will complete the game resolution of a minimum of 16 outcomes per entry however the selections for the fixture list will only be determined on the first 8 outcomes, meaning the 1st half results. The second 8, meaning the second half will be set as all results payable on the system when resulting.
- 1.2. The promoter hereby imposes the following Promotional terms and conditions in terms of Section 36 of the POPI Act with the Consumer Protection Act 68 of 2008.

2. The Participant

- 2.1. The Participant must be:
 - 2.1.1. A natural person and may not be a juristic person;
 - 2.1.2. 18 years or older;
 - 2.1.3. In possession of a valid South African Identity Document; and
 - 2.1.4. A permanent resident or citizen of the Republic of South Africa residing in South Africa.
- 2.2. It is a material term of the Promotion that all Participants' to this promotion participate entirely at their own risk.
- 2.3. No director, employee, agent or consultant of the Promoter or organizer, or their spouses, life partners, business partners or immediate family members, or the supplier of goods and services in connection with this Promotion may participate in this promotion.

3. Promotional Entry Rules

- 3.1. To enter into this Promotion, Participants will be required to:
 - 3.1.1.1. Fill out a SPORTSTAKE 8 bet slip at National Lottery retailer or on the National Lottery website or Mobile APP. Enter the minimum of 16 outcomes per list. Purchase the ticket by completing the

transaction and then wait for the results when the draw takes place.

- 3.1.1.2. By purchasing a SPORTSTAKE 8 ticket, all players are automatically included in the promotion.
- 3.1.1.3. Only approved results via the National Lottery website or National Lottery App will be acknowledged.

4. The Promotion

- 4.1. The Promotion starts: First List opens: 02 May 2022 to Last List opens 30 October 2022
- 4.2. Promotion will be awarded as follows:
 - 4.2.1. Participant who correctly matches 8 outcomes out of the first half for every list during the promotion will win the Division 1 (Jackpot) share or shares, depending on the number of winners. All subsequent divisions will function as per the SPORTSTAKE 8 game rules.

5. The Rules

- 5.1. The following rules apply to the Promotion:
 - 5.1.1. The Promoter reserves the right to amend these Promotional Rules by bringing it to the Participants attention within a reasonable period of time and may terminate the Promotion at any time.
 - 5.1.2. In such event, where the Promotion is terminated or suspended, all Participants agree to waive any rights that they may have in terms of the Promotion and acknowledge that they have no recourse against the Promoter, their promotional partners, directors, employees, agents, partners, suppliers, or sponsors.
 - 5.1.3. In the event of a dispute, the decision of the Promoter will be final and binding and no further correspondence and/or discussion will be entered into. In this regard and for further clarity, Promoter shall be entitled to deal with such disputes (or any failure by Participants to follow the Promotion Rules) in their sole discretion, including that the Promoter shall be entitled to immediately disqualify Participants from this Promotion.

- 5.1.4. By making a deposit using the National Lottery Website and the National Lottery Mobile App during the promotional period you are confirming that you will abide by these terms & conditions and you accept these terms & conditions set by the Promoter.

6. Indemnification

7.1. By entering into the Promotion, the Participant expressly agrees to the following indemnifications:

- 6.1.1. The Participant indemnifies and holds harmless the Promoter and its promotional partners, their directors, employees and their agents (“the Indemnified Parties”) of any and all liability pertaining to any damage, cost, injuries and losses of whatsoever nature and howsoever arising as a result of their participation in the promotion and related events and activities, including, without limitation, personal injuries, death, and property damage, and claims based on publicity rights, defamation or invasion of privacy; and
- 6.1.2. The Participant accepts that the Indemnified Parties will not be responsible for any costs, damage or otherwise, howsoever incurred by the Winner subsequent to claiming the Prize.

7. Qualification Rules

- 7.1. Participation in the Promotion constitutes acceptance of the Promotion Rules.
- 7.2. All players participating the SPORTSTAKE 8, are automatically eligible to the promotion.
- 7.3. The Promoter’s decision is final and no correspondence will be entered into.

8. POPI

- 8.1. Any personal data relating to the winners or any other entrants will be used solely in accordance with current Consumer Protection Act (CPA)/ the Protection of Personal Information Act (POPI) and will not be disclosed to a third party without the entrant’s prior consent.

- 8.2. Entry into the Promotion will be deemed as acceptance of these terms and conditions.
- 8.3. This Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter or any other Social Network.
- 8.4. The Participant by part taking in the Promotion consents to his/her personal information to be shared with the Promoter's employees, contractors or agents for the purpose of this Promotion and for the purpose of sharing future promotions.
